#### WHAT ARE COOKIES

This page informs you of our policies regarding the collection, use and disclosure of personal data when you use our Service and the choices you have associated with that data.

SERVICE

Service is the www.grahamsportbond.com website operated by John E. Fells & Sons Ltd.

#### PERSONAL DATA

Personal Data means data about a living individual who can be identified from those data (or from those and other information either in our possession or likely to come into our possession).

#### **USAGE DATA**

Usage Data is data collected automatically either generated by the use of the Service or from the Service infrastructure itself (for example, the duration of a page visit).

#### COOKIES

Cookies are small files stored on your device (computer or mobile device).

#### DATA CONTROLLER

Data Controller means the natural or legal person who (either alone or jointly or in common with other persons) determines the purposes for which and the manner in which any personal information are, or are to be, processed.

For the purpose of this Privacy Policy, we are a Data Controller of your Personal Data.

### DATA PROCESSORS (OR SERVICE PROVIDERS)

We may use the services of various Service Providers in order to process your data more effectively.

#### DATA SUBJECT (OR USER)

Data Subject is any living individual who is using our Service and is the subject of Personal Data.

#### INFORMATION COLLECTION AND USE

We collect several different types of information for various purposes to provide and improve our Service to you.

#### TYPES OF DATA COLLECTED

#### **Personal Data:**

While using our Service, we may ask you to provide us with certain personally identifiable information that can be used to contact or identify you ("Personal Data"). Personally identifiable information may include, but is not limited to:

#### Examples of Cookies we use:

If you are from the European Economic Area (EEA), John E. Fells & Sons Ltd. legal basis for collecting and using the personal information described in this Privacy Policy depends on the Personal Data we collect and the specific context in which we collect it.

John E. Fells & Sons Ltd. may process your Personal Data because:

- We need to perform a contract with you
- You have given us permission to do so
- The processing is in our legitimate interests and it is not overridden by your rights
- For payment processing purposes
- To comply with the law

#### RETENTION OF DATA

John E. Fells & Sons Ltd. will retain your Personal Data only for as long as is necessary for the purposes set out in this Privacy Policy. We will retain and use your Personal Data to the extent necessary to comply with our legal obligations (for example, if we are required to retain your data to comply with applicable laws), resolve disputes and enforce our legal agreements and policies.

#### LEGAL REQUIREMENTS
